## Report of the Selectmen.

---

Contrary to the usual custom, the present board have decided to present a brief history of their management of the various departments under their control, and to make certain recommendations for the consideration of the voters at the next annual meeting. It has been their aim to conduct the affairs of the town in an impartial and business-like manner, and to the satisfaction of the citizens of all sections.

---

### TOWN OFFICERS.

As there is no fixed compensation for the officers of the town, we would recommend that a committee be appointed to report at a future meeting the salary that each town official should receive, and also that a special appropriation be made for town officers, thus separating it from contingencies.

### DEPOT CEMETERY ADDITION.

The selectmen were instructed at the last annual meeting to acquire additional land for the cemetery at the Depot Village, but after two meetings with the Cemetery Association, and consulting with other citizens as to the amount of land that should be taken, we found there was such a wide difference of opinion (varying from three to forty acres) that we decided to submit the whole matter to the town without any recommendation.

### HIGHWAYS.

By vote of the town we were instructed to expend two thousand dollars for permanent work on the roads. We found ourselves unable to keep the Highways in a safe and passible condition for less than about three thousand dollars, leaving a balance of about fifteen hundred dollars which still remains unexpended. The last of the year being a very busy time with the quarries, we were unable to obtain the stone for the work of permanently improving the roads, and during the early part of the year not being certain how much we could save from our appropriation, we did not deem it prudent to expend two thousand dollars for permanent improvements, and then later on have to exceed the sum left for ordinary repairs. We are of the opinion that about the same sum would be sufficient for ordinary repairs the coming year, and with the same appropriation as last year (\$4,500) would leave about three thousand dollars for permanent work. This, together with from six to twelve thousand, which the State Highway Commissioners have promised to expend for state highways in the town, would make a very creditable showing for the ensuing year.

### BRIDGES.

We found the bridges of the town in a very poor condition, and after expending substantially the full amount of the appropriation, (\$1000) we feel they are still in a very unsatisfactory state. In December the board examined all the bridges of the town, five of which were in very poor condition, namely, Burleigh's, the canal bridge and bridge to the Athol depot at Three Rivers, wooden bridge at Bondsville, and canal bridge at Thorndike. We would recommend new iron bridges at Bondsville and Thorndike, at an expenditure of thirteen hundred dollars. *← Canal*

We found the Burleigh bridge in need of new trusses, new planking, and generally in need of very extensive repairs. It is a question for the town to consider, whether it would not be good economy to replace the old structure with a new iron bridge.

## SEWERS AND CULVERTS.

During the year new sewers have been constructed at Three Rivers, Bondsville, and the Depot Village. The sum of (\$495) four hundred and ninety-five dollars has been collected for entrances. We have made efforts to collect all accounts that we had any knowledge of, but we feel that there is money still due the town for entrances made in past years. In our effort to collect the fee that has been so long carried in the accounts of the town as due from H. P. Holden for sewer privilege, we were stopped by a temporary injunction issuing from the superior court. We hope for an early trial of the case against us, when the right of the town in this matter will be determined.

After the board of health has completed its work of compelling abutters to enter the sewers, it will be easy from an inspection of the record of past payments to ascertain what persons, if any, are indebted to the town for old entrances.

The town can then take such action as it deems proper to compel payment of those fees.

### SUPPRESSION OF ILLEGAL LIQUOR SALES.

This has been the most difficult problem with which we have had to deal, and while we have endeavored to be energetic and vigilant, we feel that we have not prevented the illegal sale of liquor in the town.

The officers have served ten search warrants in the town during the year, securing liquors in seven cases, which after the usual proceedings were declared forfeited to the Commonwealth. Nine cases have been brought against six persons for various offences against the liquor law, and in every case the offender has been convicted. The result has been the payment of fines amounting to five hundred and fifty dollars, (\$475 to the town and \$75 to the county), and the permanent removal from town of two of the worst and most persistent offenders the town has ever had to deal with.

## REPORT OF THE LIBRARIAN

FOR THE YEAR ENDING MARCH 1, 1896.

The library has received a much larger accession of new books the past year than ever before in its history, as a result of the increase in the appropriation by the town. The figures are as follows:—

There have been 12,273 volumes drawn during the year, of which 9385 were fiction and 2888 other classes. The call for books was somewhat sluggish in the early part of the library year, but the acquisition of the new volumes gave a decided impetus to the circulation. # Report of the Board of Health,

FROM MARCH 1st, 1895, TO FEBRUARY 29, 1896.

The whole number of cases reported, of contagious diseases, was 92; some cases were not reported that should have been, which would have increased the number to over 100. The year previous, 41 was the number reported.

Of the cases reported 79 were of scarlet fever, 8 of diphtheria, 3 of typhoid fever, 1 of measles, 1 of croup; (9 cases of croup not reported.)

The locations of the contagious diseases were as follows: 3 in Palmer, 4 at Carpet Mill, 10 at Bondsville, 31 at Three Rivers and 44 at Thorndike.

Deaths reported, 158. March, 23; April, 16; May, 16; June, 12; July, 13; Aug., 22; Sept., 5; Oct., 8; Nov., 13; Dec., 9; Jan., 16; Feb., 5.

## CAUSES OF DEATH REPORTED.

Scarlet fever, 24; pneumonia, 17; cholera infantum, 14; croup, 10; heart disease, 8; consumption or tuberculosis, 7; convulsions, 5; meningitis, old age, premature birth, apoplexy, 4 each; Brights disease, still born, acute saryngitis, 3 each; typhoid fever, suicide, hemorrhage, nephritis, bronchitis, peritonitis and aneurism, 2 each; and quite a number of other diseases of one each, diseases not enumerated.

The mortality is large in this town, especially among children, 57 were under 5 years of age; 13 reported over 70, 5 of these between 80 and 90 years old.

It is to be regretted that so many tenement houses are so crowded; and if continued we must look for a larger death rate; public sewers

by everyone's door will not give proper ventilation or cleanliness inside these houses, nor put shoes and stockings on the children's feet in mid-winter. The state compels towns to ventilate their school-houses under a penalty. The children above 5 years old are supposed to be in school about six hours a day, five days in a week. How is it with those under 5 years old, spending 24 hours a day, seven days in a week, in a badly ventilated house? Another cause, giving contagion a good opportunity to spread: Children are obliged to use school books indiscriminately, and slates also. The state by law obliges the towns to furnish books for the school children. A child may have a book to-day while just "coming down" with one of the worst of contagious diseases; tomorrow another child may use the same book, the germs are fresh, the latter child takes on the disease and the wonder is where the child caught it. The state has the authority to make the towns do in this way, but who would not prefer to buy the books for their own children than take these risks?

The sewers ordered at the last annual meeting of the town have been built; many have entered and paid for so doing. All others who have not entered will receive legal notice in the early spring to do so.

The board has attended to all legal notices received by them of nuisances, and they have been abated; we have also been called to see a number of tuberculous cattle, and examined diseased meat, when notified by the Inspector.

We would recommend that \$200 be raised for use of Board of Health.

D., 1896, at half past six o'clock in the forenoon, then and there to give in their votes on one ballot to the precinct officers of the several voting precincts of said town for the following town officers, to wit: Three selectmen, three assessors, a town clerk, a town treasurer, a collector of taxes, two auditors, five constables, three fence viewers, all for the term of one year; one overseer of the poor for the term of three years; two member of the school committee for the term of three years; one member of the school committee for the term of two years; also a board of health to consist of three members, one for the term of three years, one for the term of two years, and one for the term of one year; also to vote by ballot, which shall be Yes or No, in answer to the question, "Shall licenses be granted for the sale of intoxicating liquors in this town?"

The polls will be open at half past six o'clock in the forenoon, and may be closed at three o'clock in the afternoon.

And you are further hereby required to notify and warn the inhabitants of said Palmer, qualified to vote in town affairs, to meet at the Town House, at Four Corners, in said Palmer, on Monday, the 30th day of March, A. D., 1896, at ten o'clock in the forenoon, then and there to act on the following articles, viz. :

- x ARTICLE 1. To choose a moderator to preside at said meeting.
- x ART. 2. To choose two or more field drivers, measurers of wood and bark, and all other usual town officers.

- X ART. 39. To see if the town will take any action in regard to funding its debt.
- X ART. 40. To see if the town will vote to make repairs on the grammar school building at the Depot Village, in accordance with the order of the State Inspector, or pass any vote, or take any action relative thereto.
- X ART. 41. To see if the town will vote to construct a sidewalk from the iron bridge to the French Catholic church, on the northerly side of Main street, in Three Rivers, and raise and appropriate money for the same, or take any action relative thereto.
- X ART. 42. To see if the town will vote to hire the present tramp room and lock-up. same as before

And you are hereby directed to serve this warrant by posting up attested copies thereof at the different public places designated by the vote of the town, seven days at least, before the holding of said meeting, and cause this warrant to be printed in the Palmer Journal at least two issues before the holding of said meeting.
