20 February. Deposition by Thomas Parker of St. Martin in the Fields, Middlesex, gent, that George, Earl of Orkney, has appointed Hon. Alexander Spotswood, Lieutenant-Governor of Virginia, as his attorney. (LMC).

23 February. Shipper by the *Friendship* of Whitehaven, Mr. Isaac Langton, bound from Whitehaven for Virginia: Thomas Lutwidge. (PRO: E190/1451/13).

24 February. Deposition by William Watkinson of London, mercer, that by deed of 6 March 1705 Alexander Paxton of Philadelphia became indebted to Edward Richier of London, merchant. (LMC).

24 February. Oxford Circuit prisoners reprieved to be transported to America. Gloucestershire: Thomas White of Newent; Edward Townsend *alias* John Eldridge of Stow on the Wold; William Wale *alias* Isles of Cowley, yeoman; David Jenkins of Bristol; John Coleman of Frampton Cotterell, yeoman. Shropshire: Thomas Humphreys of Dawley, yeoman. Staffordshire: Joseph Brown of Harborne; Arthur Carter of Burton on Trent. (C66/3494/6).

February. Grants made in the Prerogative Court of Canterbury, London: Probate of will of Humphrey Todd of H.M. ship *Deptford*, who died on H.M. ship *Adventure* in Boston, New England; Administration of Francis Price of Maryland, bachelor. (AW).
