THE MACKERWITHY - MACKWETHY - McWETHY
McQUIVEY - QUIVEY FAMILY

FIRST GENERATION

1. JAMES¹ MACKERWITHY, the first of the name in New England, was born in Scotland and settled at Dedham, Mass., by 1661, where he probably died between 1700 and 1709. He married there (1) in Nov. 1662, MARY EVERETT, who was born there 28 Sept. 1638, and died there 13 June 1670, daughter of Richard Everett; (2) 20 Feb. 1670/71, at Dedham, PATIENCE CUBBY; and (3) before 1673, EXPERIENCE . It is possible that James Mackerwithy's second and third wives were actually the same person, for no death for Patience was recorded and no marriage to Experience has been found. The two names are somewhat similar, and the clerk could have mistakenly written Patience instead of Experience in the marriage record. The children who were born after 1670 were recorded as children of James and Experience.

There was a tradition in the family of the late Lou D. MacWethy of St. Johnsville, N.Y., that the first ancestor of this family was brought to New England by the English in a convict ship. In 1650 and 1651 Cromwell defeated the Scots in battles at Dunbar and other places and took many prisoners some of whom were exiled to New England. It seems likely that James Mackerwithy was one of these prisoners. Be that as it may, the records reveal that several Scottish families settled in Dedham.

James Mackerwithy's surname was spelled many ways in the Dedham records, including MacRory, and his descendants have used many variations down through the years. In a letter dated 22 Jan. 1980, to Mr. Vallie R. Weethee, then of Haines City, Florida, Dr. Micheil MacDonald of the Museum of Scottish Tartans, Comrie, Perthshire, Scotland, wrote:

After the defeat of the Scots by Cromwell at Dunbar, many were transported to New England. Your forbear used both his PATRIONYMIC (sic) surname " mac Ruaidhri " and that of his clan " 'Clànn 'ic Cuithean ". The first gives him roughly MacRory in English and the second MacQuithy or MacWithy. Men often were known by different names in different places or by different people.....More anon if you wish. (Ruairaidh Maccuithean was story-teller to Lord Macdonald in 16th C.)

From 1661 to 1685 James Mackerwithy's name appears in Dedham town records as Macarory, Mackarora, Mackrora, Mackrorey, Mackrorie, Mackrory, Makarory, Makrora, Makrory, etc. From 1665 to 1670 it was written Mackrory in the Dedham church records. In 1663 the spelling Makerwitha appears in the town records and Makerwithea in the vital records. Other spellings in the vital records are Mackerwithy, Makerwithey, Makerwithy, etc. From 1674 and exclusively after 1685 some form of Mackerwithy (Macarwethy, Macarwithe, Macarwithy, Macawithy, Macconwithy, Macorwithy, Makerwethe, Makerwethy, Makerwitha, Makerwithe, Makerwithy, Makurwitha, etc.) was used in the town records. After 1685 the name MacRory and its many variations no longer appear.

James Mackerwithy appeared on tax lists in Dedham from 11 Feb. 1660/61 to 11 Nov. 1700 [Dedham Records, 4:33; 5:283]. In 1662 he was charged 2 shillings by the town as he was one of several inhabitants of Dedham who were "deffectiue in there highway worke" [ibid., 4:51]. At a meeting of the selectmen of Dedham on 11 Mar. 1662/3, "James makurwitha moue for a parcell of Land beyond John Makintoche to the Value of 2 acres and a 1/2 due to Rich: Everit for purchase Land intendinge to build a hovse vpon it" [ibid., 4:61]. At another meeting on 26 Dec. 1665, "James Mackrorey coming and desireing the grant of 5 acres of vpland vpon the gift of his Father in lawe Richard Euered. being a right of Land by him purchased of Danll Mackiah. who purchased the same of Thomas Jordan...this his request is granted and Lieft: Fisher Robt Fuller and John Farington are deputed and empowered to laye it Out to the said James some where neere his house according to thier best discretion" [ibid., 4:107-108]. At a town meeting held on 1 Jan. 1678/9, John Bacon, Sr. and Thomas Metcalf were chosen a committee "to vew a porsel of land for John Pigge and for Jams Macarory: and to make returne to the propriators: of this Town the 10th day of march next"; and on 10 Mar. 1678/9, the town "Granted to Jams Macarory to the quantity of 2 or 3 Acres o[f] lande to be set out by John Bacon and Ser Tho Metcalf neere ajoyning to his lot" [ibid., 5:76, 80].

In his will, dated 12 May 1680 and proved 25 July 1682, Richard Everett bequeathed seven acres of upland to James Mackerwithy for the term of his natural life after which it was to be equally divided among "my three grand children: James Daniell and Mary Mackerwithy being the Children that he sd Mackerwithy had by my daughte^r Mary". [Everett, Edward Franklin, Descendants of Richard Everett of Dedham, Mass. (1902), p. 17].

The last record in which James Mackerwithy, Sr. appears is the tax list of 11 Nov. 1700. His son James appears with the designation "Jr." on tax lists through Aug. 1708, so it would appear that James Mackerwithy, Sr. died between 1700 and 1709.

SECOND GENERATION

2. DAVID² MACKWETHY, son of James¹ and Experience Mackerwithy, was born 17 Apr. 1678, in the Town of Dedham, Norfolk (then Suffolk) Co., Mass., and died 10 June 1756, in the Town of Preston, New London Co., Conn. He married about 1702, probably at East Hampton, L.I., N.Y., ELIZABETH _____, who was living in 1765 and was probably the Widow Mackwethy who died 7 Mar. 1772, in Preston.

David Mackwethy was a weaver by trade and moved from Dedham, Mass., to East Hampton, Long Island. He first appeared in the records there on 26 Nov. 1703, when he purchased 5 acres of land "at a place commonly called Wainscot" for £4 5s. from Ephraim Osborne of East Hampton, husbandman. Ephraim and Elizabeth Osborne signed the deed. [Records of the Town of East-Hampton, Long Island, Suffolk Co., N.Y., 3:77.] David "Macwithie" of East Hampton, weaver, sold this land 31 Oct. 1710, to Nathaniel Parke of Shelter Island, N.Y., for £40 and his wife Elizabeth surrendered all right of dowry. [Ibid., 3:260-261.] On 22 July 1711, David, James and John "children of David Macerwithy" were baptized at East Hampton and on the same date "The wife of David Mackerwithy" owned the covenant. [Ibid., 5:456, 428.]

On 31 Oct. 1710, the same day he sold his East Hampton land, David "Mackerwithee" purchased from Nathaniel Parke of Shelter Island, cooper, for £40 about 70 acres in Preston, Conn., bounded partly on the commons near Ebenezer Williams. [Preston Deeds, 3:10.] On 14 May 1716, there was laid out to "David Mackerlithee an Addition of Land to Make his former Lott in Quantity for what itt wanted in Quallity of ye other Lotts." [Ibid., 3:66.] David Mackwethy sold land on 12 Nov. 1725, to his son David; on 13 Feb. 1731/2, to his son James; on 29 Mar. 1731/2, to his son John; and on 2 Sept. 1743, to his son Ephraim. [Ibid., 4:379, 1037; 5:390, 405.]

The will of David "Mac wethy" of Preston, dated 21 Apr. 1756 and proved 6 July 1756, mentions his being weak and under difficult circumstances. He left his beloved wife Elizabeth all moveables except his broad axe and great Bible. These two treasures he left to his son James as well as land southwardly of James's own land. To his daughter-in-law "Marcy" he left the improvement of forty acres of land, after his wife's decease, during her lifetime; and after Mercy's decease it was to go to his two grandchildren the heirs of his son Ephraim deceased. All the remainder of his lands and buildings were bequeathed to his wife. To each of his two sons, David and John, and his two daughters, Elizabeth Mulkins and Sarah Griffith, he gave five shillings. He named his son James executor. The witnesses were Peter Harris, John Coye and John Green, Jr. He signed his name "David mack wethy" to this document. [Original will, Estate of "David Macwethy," File #7403, Norwich Probate District, at Connecticut State Library, Hartford, Conn.] The inventory was taken 5 July 1756, by Stephen Tucker and Elijah Belcher, and the only land mentioned was the farm where he had lived. [Norwich Probate District, 1:450.]

On 31 Jan. 1757, the widow Elizabeth "Macswethy" (also spelled "Mac wethy" in this document) leased to her grandson, Lemuel "Macswethy" (also spelled "Mac wethy" in this document) leased to her grandson, Lemuel "Macswethy" (also spelled "Mac wethy" in this document).

wethy" or "Mac wethy," part of the land her dearly beloved husband David gave to her in his last will and testament. [Preston Deeds, 7: 490.] On 3 Apr. 1765, Elizabeth "Macwethy," widow, and Stephen Gates and his wife Mercy, all of Preston, "Doth farm Let and Get" to David Green and his wife Mary of Preston, for and during the term of the natural lives of the said Elizabeth and Mercy, land given to the said Mary, wife of David Green, and Elijah, her brother, by David "M^cwethy" in his last will and testament. [Ibid., 8:205.] This is the last record found for Elizabeth. She was probably the Widow Mackwethy whose death on 7 Mar. 1772, is recorded in the records of the North or Second Church in Preston (now the Griswold Congregational Church) [p. 155, typed MS at Connecticut State Library].

THIRD GENERATION

3. JOHN³ MACKWETHY, son of David² (James¹) and Elizabeth Mackwethy, was baptized 22 July 1711, at East Hampton, Long Island, New York. He married 22 May 1738, in the Town of Preston, New London Co., Conn., ELIZABETH LUCE, daughter of Josiah and Sarah (Allen) Luce of Windham, Conn.

John Mackwethy and his wife Elizabeth were admitted to the North or Second Church in Preston on 12 Aug. and 16 Sept. 1739, respectively, and all their children were baptized in this church. Thus it would appear that they lived in the north part of the Town of Preston which became the Town of Griswold in 1815.

On 29 Mar. 1731/2, David "Mackqueathey" sold for love, good will and affection to his son John a parcel of land in Preston, Conn. [Preston Deeds, 5:390.] On 24 Aug. 1739, John "Mackwethy" and his wife Elizabeth of Preston sold 3 1/2 acres of land in Windham, Conn., to Edward Waldo. [Windham Deeds, H:1.] This was bounded in part by "ye Widow Luces thirds" so undoubtedly was land inherited from Elizabeth's father, Josiah Luce. Then on 8 Oct. 1743, Joshua Luce, Jonathan Luce, John "mackwethy," Ephraim "mackwethy" and Sarah Luce for £70 sold to Nathaniel Luce all their rights of land in the estate of Jerusha Luce late of Windham deceased; and on 2 Oct. 1747, John "Macquethy" and his wife Elizabeth and Ephraim "mackquethy" and his wife Marcy, all of Preston, sold to James Lasell of Windham all their rights to 2/10 part of 27 acres of land in several tracts in Windham "set out to our Honored mother Sarah Luce Late of sd windham decesed as her thirds of ye Real Estate of our honored father Josiah Luce Late of sd Windham decesed." [Ibid., H:227; I:104.] John "Macwithy" and his wife Elizabeth and "Marcy Macwithy singel woman," all of Preston, sold land in Kent, Conn., for £220 to Nathaniel Cushman on 12 June 1754. [Kent Deeds, 2:126.]

David "Mackwethy" of Voluntown, Conn., sold 1 3/4 acres and 14 rods of land for £27 to John "Macwethy" (also spelled Mackwethy in the body of this deed) of Preston on 10 May 1748. Then on 23 Jan. 1756, "John Mackwathy Late of Preston Now Dwelling in Crumel bow presink in Duches County and in ye province of New york" sold this land to John Partridge of Preston for £60. He signed his name "John Mackwethy" to this deed. [Voluntown Deeds, 3:217; 4:169.] John Mackwethy (Maquestry, Maquethy, McQuiver, McWithty, etc.) appears on the tax lists of Crum Elbow Precinct, Dutchess Co., N.Y., from June 1757 to Feb. 1762 and of Amenia Precinct (formed from Crum Elbow 20 March 1762) from June 1762 to Feb. 1763. The tax list for the year 1764 is missing, but he was undoubtedly still living there as his son Nathan was married there that year. No further record of John Mackwethy has been found. He perhaps returned to Connecticut as did his son Nathan.

FOURTH GENERATION

4. NATHAN⁴ McQUIVEY, son of John³ (David², James¹) and Elizabeth (Luce) Mackwethy, was born 5 May 1739, in the Town of Preston, New London Co., Conn.; was baptized 16 Sept. 1739, in the North or Second Church in Preston (now the Griswold Congregational Church); and died about 1823-1826, "being aged from 84 to 87 years" [Hendee MS], in the Town of Williston, Chittenden Co., Vt. He was married (1) 8 July 1764, in Dutchess Co., N.Y., by Roswell Hopkins of Amenia, N.Y., "one of His Majesty's Justices of the Peace for the County of Dutchess," to RACHEL HENDEE, who was born 29 Oct. 1741, in the Town of Coventry, Tolland (then Windham) Co., Conn., and died "in the prime of life in Connecticut" [Hendee MS], probably by 1778, in the Town of East Windsor, Hartford Co., daughter of Jonathan and Martha (Millington) Hendee; (2) to ROXANA ELLSWORTH, who was born about 1759, and died 7 Aug. 1815, aged 56 years, in West Springfield, Mass., daughter of Charles and Betsey (Bell) Ellsworth of East Windsor; (3) to _____, probably the Mrs. Anne McQuivey who died 15 Sept. 1820, aged 77 years, at Williston, Vt.

Nathan McQuivey's surname is found spelled numerous ways in the records and a new spelling appears - McQuivey. He apparently used the spelling McWethy for some years but eventually adopted the spelling McQuivey, which was used also by his sons Solomon and Nathaniel, while his sons Jonathan and Nathan used Quivey. An explanation of the change in the spelling of the name is found in Andrew N. Adams' A History of the Town of Fair Haven, Vermont (1870), on page 25: "... McWithey, called by the old people 'McQuivey,'..."

Nathan McQuivey served in the Revolutionary War and his name, spelled McWavy, appears on the Lexington Alarm list from East Windsor in 1775. His name, spelled McQuavy, appears on the pay roll of Capt. James Fitch's Company commanded by Major Nathaniel Terry in Lt. Col. Pitkin's 19th (Conn.) Regiment. He had 46 days of service and arrived in New York on 24 Aug. 1776. [Collections of the Connecticut Historical Society, 8:2, 165.]

Just when the McQuiveys left Dutchess Co., N.Y., for Connecticut is not known, but Nathan and his brother-in-law, Richard Hendee, witnessed a deed in the Town of East Windsor, Hartford Co., Conn., on 21 Dec. 1773. [East Windsor Deeds, 2:72.] Nathan "M^Cquivey" of East Windsor purchased land there from Richard Hendee of East Windsor on 5 Feb. 1774. [Ibid., 2:60.] On 19 Jan. 1778, Nathan "M^CWethy" sold his land in East Windsor to Ephraim Grover of Coventry [Ibid., 2:230]; and on 28 Mar. 1778, "Nathan M^CTehy of Windsor Goshen" (a name sometimes used for Ellington Parish in East Windsor), Hartford Co., Conn., bought land in West Springfield, Mass., from Eldad Barker of West Springfield. [Hampshire Co. Deeds, 15:192, at Hampden Co. Registry of Deeds, Springfield, Mass.] Nathan "M^CWethy" of West Springfield quit-claimed to William Boyd on 6 Sept. 1787, a tract of land and a house in West Springfield. [Ibid., 28:455.] On 16 Mar. 1789, a writ was issued "To, the Sheriff of the County of Hampshire his under Sheriff, or Deputy or either of them Constables of the town of West Springfield ...Because Nathan M^CWithy of Springfield...husbandman on the twelfth day of January...1789 before me Samuel Mather Esq[ui]t...Justice of the

Peace...acknowledged by Non appearance that he was indebted to Samuel Hulburt of Sharon in the County of Litchfield and state of Connecticut Gent." in the sum of £35 8s. 3d., plus 25s. 10d. "cost of Process" and 16d. "for this Writ." To satisfy the debt 3/4 of an acre of land with a house and half a barn in West Springfield belonging to Nathan McQuivey was sold on 31 Mar. 1789. [Ibid., B Execution: 526-527.]

Nathan "Withee" appeared on a tax list of West Springfield dated 28 Feb. 1787; and in 1807 and 1808 Nathan and John "McWithey" appeared on West Springfield tax lists for those years. [Data from Grace M. (Mrs. William C.) Clark, 142 South West St., Feeding Hills, Mass., 1961-62.] In the 1790 Census Nathan "McWorthy" is listed under the Town of West Springfield, Hampshire (now Hampden) Co., Mass., with himself, 3 males under 16 and 1 female in his household. In the 1800 Census he appears under the name of "Nathaniel McWethy" in the Third Parish of West Springfield (which was set off as the Town of Holyoke in 1850). He was aged 45 and over and in his household were 2 females between 26 and 45, 1 male between 16 and 26 and 1 male between 10 and 16. Nathan "McWithey" is listed in the 1810 Census in West Springfield his household consisting only of himself and 1 female both aged 45 and over. In 1820 he was undoubtedly living in the Town of Williston, Chittenden Co., Vt., with his son Nathaniel for the census lists 2 males and 2 females aged 45 and over in Nathaniel's family.

Rachel (Hendee) McQuivey had a brother, Caleb Hendee, who was an early settler of Pittsford, Vt. Dr. A. M. Caverly in his History of the Town of Pittsford, Vt. (1872) mentions a manuscript Hendee family history written by Caleb Hendee's son, Gen. Caleb Hendee of Pittsford, who was thus a nephew of Rachel (Hendee) McQuivey. By an unusual circumstance, I located a copy of this manuscript (the original remains unlocated) in the possession of the Hendee Reunion Organization, Lee W. Hendee, historian, Portland, Mich., in 1953 and found that it contained valuable data on this family. Started in 1827, the manuscript is entitled "Genealogical and Biographical sketch of the family of Caleb Hendee, son of Deacon Caleb Hendee; and of his wife Lydia, and their different family connections, written by himself in the fifty-ninth year of his age, for the use and benefit of his children and grandchildren." Gen. Hendee stated that his father "had two brothers and two sisters by his mother's side. viz. Jonathan and Richard, Rachel and Martha" and that Rachel married Nathan McWethy or McQuivey. The following is a copy of that part of the Hendee manuscript which pertains to the McQuiveys:

"I now return to my father's oldest sister Rachel. She married a man by the name of Nathan McWethy (or McQuivy) by whom she had a number of children, the names of some of them I remember viz. Jonathan, Solomon, Joshua, Nathan and Nathaniel and also a daughter and perhaps more. Jonathan, her son, I understand went into the state of New York and married a dutch woman by whom he had several children. He has been dead many years. While a young man he lived with my father one season while I was a boy since when I have never seen him. His brother Solomon learned the trade of gunsmith, has a family, and has for more than twenty years worked at the same in the United States Armory in Springfield, Mass., where I suppose he now resides. He was here with a daughter of his a year or two ago. Joshua, his brother, I have never seen since I was a small boy, and know not what has be-

come of him. Nathan, his brother, lived in this town some years about 34 or 35 years since after which he went to the Genessee country in the state of New York, married a dutch girl, had a numerous family as I was told. I have not heard from him in some years. Nathaniel, the youngest son of my aunt Rachel, lived some years in this town and part of the time with me. He married for his first wife, Sally Hall, daughter of John Hall, and moved with her to Williston in this state. She did not live many years. He afterwards married again and still resides at Williston. I consider him to be a very industerous honest man. I believe he had but one sister and she married a man by the name of Downe[r] in Williston. My aunt Rachel is said to have been a woman of great strength of bodily powers, but she died in the prime of life in Connecticut. Her husband afterwards married Roxana Ellsworth, a cousin of my mothers. She has also been dead many years and my uncle McWitty moved to Williston, where he married his third wife. He died a few years since, being aged from 84 to 87 years."

Quivey, University of Utah, Salt Lake City, wrote in a letter dated 15 May 1921: "According to my father William W. Quivey, shortly after the Revolution, four brothers by the name of MacQuivey settled in Western N.Y. some eighteen miles from Buffalo. Of these he had been informed of the names of two, Nathan & Joshua. Both of these at sometime changed their name to Quivey. Joshua died a single man." I doubt that four brothers settled in western New York, but Joshua was undoubtedly living with his brother Nathan in 1800 in the Town of Northampton, Ontario Co., N.Y., for there were two males aged 26-45 listed in Nathan's family in the census of that year.

FIFTH GENERATION

5. JONATHAN⁵ QUIVEY, son of Nathan⁴ (John³, David², James¹) and Rachel (Hendee) McQuivey, was born about 1765, in Dutchess Co., N.Y., and was living in 1810 in the Town of Halfmoon, Saratoga Co., N.Y., where he probably died within a few years. In 1827 he had been dead "many years" [Hendee MS]. He married POLLY HART of Halfmoon.

Jonathan was probably the eldest son of his parents and was so listed by his cousin, Gen. Caleb Hendee. His birth could not have been later than 1765, for Gen. Hendee stated that "While a young man he [Jonathan] lived with my father [Caleb Hendee of Pittsford, Vt.] one season while I was a boy" and Gen. Hendee was born 21 Oct. 1768. Also, in the Census of 1810 Jonathan was enumerated in the 45 and over age bracket thus born in 1765 or before. Since his parents were married in 1764, he was almost certainly born in 1765. Jonathan's son, Nathaniel Quivey, stated in the 1880 Census that his father and mother were born in New York State. In addition to the above Gen. Hendee also wrote in his manuscript in 1827: "Jonathan...I understand went into the state of New York and married a dutch woman by whom he had several children. He has been dead many years." This statement that Polly Hart was Dutch confirmed a tradition in the compiler's family. My great aunt, the late Mrs. Alice May (Parsons) Hammond, told me that her mother, Mariah (Flatt) Parsons, granddaughter of Jonathan Quivey, had told her that she had Dutch ancestry. (Later a cousin of my father's told me that her grandmother, Mariah Parsons, told her she had Mohawk Dutch ancestry.) At the time we were not sure where the Dutch came into the family. The only likely candidate was Polly Hart although her name did not sound particularly Dutch. However, later research revealed that a Nicholas Hart lived in Halfmoon and appeared in the records of the Albany and Schenectady Dutch Churches. Polly was perhaps a daughter of Nicholas Hart and a sister of Catherine Hart, wife of Jonathan's brother Nathan.

Jonathan Quivey undoubtedly moved from East Windsor, Conn., to West Springfield, Mass., with his father about 1778. Sometime in the 1780's he lived for a short time with his uncle in Pittsford, Vt.; and before 1790 he removed to the Town of Halfmoon, Saratoga (then Albany) Co., N.Y., where he was enumerated in the census of that year as "Jonathan Qewoy" (according to the printed census but the original on microfilm reads "Quvoy"), his family consisting of himself and two females. In the 1800 Census Jonathan's family consisted of himself and his wife aged between 26 and 45, 2 males under 10, 1 female 10 to 16, and 1 female under 10. He was the first person enumerated in the Town of Halfmoon in the Census of 1810, and his family consisted of himself and his wife aged 45 and over, 1 male and 1 female 16 to 26, 1 male and 1 female 10 to 16, and 1 male under 10.

Jonathan Quivey apparently lived in that part of the Town of Halfmoon which was set off as the Town of Clifton Park in 1828, at least during the last years of his life; for on 10 July 1810, Jonathan, Mary, and Elizabeth Quivey were listed under Clifton Park in the Saratoga Circuit of the Methodist Episcopal Church. Jonathan and Mary, undoubtedly his wife, were marked as married and Elizabeth, probably their eldest daughter, was marked as single. [Methodist Epis-

copal Church Vol. 408, Saratoga Circuit, 1810, in Manuscripts and Archives Division, New York Public Library, New York City; Becker, Howard I., Methodist Episcopal Church Saratoga County Circuit Class Book of Rev. Mitchell B. Bull, 1810 (1959), p. 9. The published reference is in error in listing Mary as single instead of married.]

Jonathan Quivey was not found in Halfmoon in the 1820 Census, so he probably died before that time. In 1830 Polly Quivey was probably living with her son Barnabas in the Town of Butler, Wayne Co., N.Y. At that time Barnabas Quivey was a single man and living with him, among others, was a woman aged between 60 and 70.

Wadsworth of the Town of Huron, Wayne Co., N.Y., told the compiler that he could remember when he was a small boy, while out riding with his grandfather Barnabas⁶ Quivey, his grandfather pointing to a small graveyard by the road between Wolcott and Red Creek, Town of Wolcott, Wayne Co., N.Y., and saying that he had a sister buried there. No trace of the grave can be found today and only one grave in the plot is (or was) still marked. The grave was perhaps that of the girl listed in Jonathan's family in the 1790 and 1800 (aged 10-16) Censuses. An Elizabeth Quivey, a single woman, was a member with Jonathan and Mary Quivey, probably her parents, in the Clifton Park Methodist Episcopal Church in 1810.

6. SOLOMON⁵ McQUIVEY, son of Nathan⁴ (John³, David², James¹) and Rachel (Hendee) McQuivey, was born about 1767, and died 27 Apr. 1845, aged 87 years [Warren MS], at Springfield, Mass. This age is probably a misreading for 77 for as given it places his birth six years before the marriage of his parents. He married (1) 10 Feb. 1791, at North Bolton (now Vernon), Conn., CHARITY SIMONS, who died 17 Aug. 1825, aged 57 years, at Springfield; (2) in Nov. 1826, ELIZABETH (ALLEN) BOSTWICK, who was born in Litchfield, Conn., and died 10 May 1857, aged 70 years, at Providence, R.I., widow of David Bostwick and daughter of Joseph and Anna Allen.

Solomon McQuivey bought land in East Windsor, Conn., 8 Nov. 1790 [East Windsor Deeds, 6:102] and 4 Mar. 1796, in Springfield, Mass. [Hampshire Co. Deeds, 38:129], where he was living in 1800. His cousin, Gen. Caleb Hendee, stated in 1827 that "Solomon learned the trade of gunsmith, has a family, and has for more than twenty years worked at the same in the United States Armory in Springfield, Mass., where I suppose he now resides. He was here [Pittsford, Vt.] with a daughter of his a year or two ago."

The will of Solomon McQuivey is dated 27 Jan. 1844. He gave his personal estate and his dwelling house to his wife Elizabeth to hold during her life. All the residue and remainder of his real estate he gave to "my own right heirs." [Estate of Solomon McQuivey, Case No. 7616 and Wills, 16:408, Hampden Co. Registry of Probate, Springfield, Mass.]

7. NATHAN⁵ QUIVEY, son of Nathan⁴ (John³, David², James¹) and Rachel (Hendee) McQuivey, was born about 1772, and died 17 Apr. 1847, aged 75 years (g.s.), in Bedford Township, Meigs Co., Ohio. He married CATHERINE HART, who was born about 1775, and died in March 1850, aged 75 years (g.s.), in Bedford Township. They are buried there in Burlingham Cemetery. Catherine Hart was undoubtedly the Catarina Hart, who was baptized 18 Oct. 1775, in the Schenectady (N.Y.) Dutch Church, daughter of Nicholas and Margaret (Haynes) Hart of Halfmoon, Saratoga Co., N.Y. The compiler has been unable to find any probate or land records for Nicholas Hart to prove this, but there is strong circumstantial evidence. Catherine (Hart) Quivey named a son Nicholas H. and her age at death coincides nicely with the baptismal record.

Nathan Quivey removed from West Springfield, Mass., to Pittsford, Vt., by 1795, where his uncle, Caleb Hendee, resided. His cousin, Gen. Caleb Hendee, wrote in his manuscript in 1827: "Nathan...lived in this town [Pittsford, Vt.] some years about 34 or 35 years since after which he went to the Genessee country in the state of New York, married a dutch girl..." Nathan purchased his first land in Pittsford from Moses Olmstead of Pittsford on 21 Feb. 1795. [Pittsford Deeds, 2: 479.] Nathan was still a resident of Pittsford on 15 Mar. 1798, when he sold three pine lots to Nathaniel Quivey of West Springfield, Mass.; but on 18 Apr. 1799, he was of Clifton Park (a part of the Town of Halfmoon until set off as a separate town in 1828), Saratoga Co., N.Y., when he purchased two pine lots in Pittsford from his uncle, Caleb Hendee. [Ibid., 3:53, 275.] Nathan Quivey of "Genesee," Ontario Co., N.Y., sold land in Pittsford to Nathaniel Quivey of West Springfield, Mass., on 20 Feb. 1800, and on 4 Jan. 1802, Caleb Hendee, Jr. (the General) quitclaimed land in Pittsford to Nathan Quivey of Genesee, Ontario Co., N.Y. [Ibid., 3:312; 5:229.]

In the 1800 Census Nathan "Quibby" is listed in the Town of Northampton, Ontario Co., N.Y., his household consisting of 2 males aged 26 to 45 (Nathan and probably his brother Joshua), 1 female aged 26 to 45, 1 male and 1 female under 10. The name Norton (undoubtedly a misreading for Nathan) Quivey appears on the first tax roll west of the Genesee River, Town of Northampton, on 6 Oct. 1800. [Foley, Janet Wethy, Early Settlers of New York State, 1:42.] In the 1810 Census Nathan "McWithey" is found in the Town of Leicester, Genesee (now Livingston) Co., N.Y., and in 1812 he was an ensign in the 161st Regiment, 6th Brigade of Genesee County in the New York State Militia. [Military Minutes of the Council of Appointment of the State of New York, 1783-1821, 2:1375.] ~~Apparently Nathan moved his family eastward at the time of the War of 1812, for his son, Joseph Smith Quivey, is said to have been born in 1814 near German Flats, Herkimer Co., N.Y.~~ About 1824 Nathan Quivey and his family removed to Meigs Co., Ohio.

8. NATHANIEL⁵ McQUIVEY, son of Nathan⁴ (John³, David², James¹) and Rachel (Hendee) McQuivey, was born about 1775, in the Town of East Windsor, Hartford Co., Conn., and died 24 June 1843, aged 68 years (g.s.), in the Town of Ripton, Addison Co., Vt. He married (1) 19 Jan. 1802, at Pittsford, Vt., SARAH (also called SALLY) HALL, who died 20 Sept. 1807, aged 28 years (g.s.), in the Town of Williston, Chittenden Co., Vt., daughter of John Hall; (2) 28 Feb. 1809, SILENCE LITTLEFIELD, who was born 7 Dec. 1785, and died at Freeborn, Minn.

Nathaniel McQuivey moved with his father from East Windsor, Conn., to West Springfield, Mass., about 1778. About 1800 or 1801 he removed to Pittsford, Rutland Co., Vt., where his uncle, Caleb Hendee, resided. On 20 Feb. 1800, Nathaniel "Quivey" of West Springfield, Mass., bought land in Pittsford from his brother Nathan; and on 15 Dec. 1801, Nathaniel "Quivey" of Pittsford sold land to Joab Powers. [Pittsford Deeds, 3:312; 5:17.] On 14 Mar. 1804, Nathaniel was a resident of Williston, Chittenden Co., Vt., when he sold land in Pittsford to Andrew Leach. [Ibid., 9:509.] He appears frequently in the deeds of Williston from 1804 to 1831, but the last deed recording him as a resident of Williston is dated 24 Apr. 1827. [Williston Deeds, 6:282.] On 10 Apr. 1828, he was a resident of Ripton, Addison Co., Vt. [Ibid., 6(2):147.]

Nathaniel McQuivey was a farmer and mill man, one of the first to be chosen selectman in Ripton, and represented the Town of Ripton in the State Legislature. He was a Methodist and built the first church in Ripton almost alone. His cousin, Gen. Caleb Hendee, wrote in his manuscript in 1827: "Nathaniel, the youngest son of my aunt Rachel, lived some years in this town [Pittsford, Vt.] and part of the time with me. He married for his first wife, Sally Hall, daughter of John Hall, and moved with her to Williston in this state. She did not live many years. He afterwards married again and still resides at Williston. I consider him to be a very industerous honest man."

She married 15 Sept. 1796, CALEB DOWNER, who was born 11 May 1772, in Conn., and died 6 Mar. 1857, at Williston, Vt., son of Caleb Downer of Colchester, Conn. Caleb Downer, Jr. removed to Williston, Vt., and is said to have made the journey on foot. Betsey's cousin, Gen. Caleb Hendee of Pittsford, Vt., wrote in his manuscript in 1827 that his aunt, Rachel McQuivey, had a daughter who "married a man by the name of Downe[r] in Williston."

HENDY⁶ QUIVEY, son of Jonathan⁵ (Nathan⁴, John³, David², James¹) and Polly (Hart) Quivey, was born about 1793, in the Town of Halfmoon, Saratoga Co., N.Y., and died 26 Feb. 1848, aged 55 years, in the Town of Hamlin (then Clarkson), Monroe Co., N.Y. He married HANNAH SPICKERMAN, who was born about 1797, in Albany Co., N.Y., and died 1 July 1868, aged 70 years and 7 months (g.s.), in the Town of Hamlin. Mr. and Mrs. Quivey are buried there in the Blossom Cemetery but Hendy has no stone.

Hendy Quivey was living in Cayuga County, N.Y., as early as 1818 as his son Henry was born there that year. In the 1820 Census he is found in the Town of Cato. He lived in that part of the Town of Cato which was set off as the Town of Victory in 1821, and he purchased land there on Lot 39 from John Hart and his wife Catharine of Victory on 23 Oct. 1827. [Cayuga Co. Deeds, JJ:41.] On 22 Feb. 1842, Hendy Quivey bought land bordering on the above from his brother Nathaniel. [Ibid., 67:194.] He bought additional land on Lot 39 on 14 Oct. 1837, from William O. Wood and his wife Lucena of Wolcott, N.Y., and on 12 Mar. 1841, from David Spickerman and his wife Isabel also of Wolcott. [Ibid., 64:621, 622.] On 19 Oct. 1843, Hendy Quivey and his wife Hannah of the Town of Victory sold their land on Lot 39 [Ibid., 67:358] and soon after moved to the Town of Clarkson (that part set off in 1852 as the Town of Union and renamed Hamlin in 1861), Monroe Co., N.Y.

The death of Hendy Quivey was noted in the Rochester Daily Democrat for 6 Mar. 1848, p. 3, col. 2, as follows: "In Clarkson, on the 26th ult., Mr. Hendy Quivy, aged 55 years." Letters of Administration at the Monroe County Surrogate's Office show that Hendy Quivey died in the Town of Clarkson 26 Feb. 1848, leaving a widow Hannah and eight children. Hannah Quivey and Aaron Van Auken were the administrators. The petition, dated 10 May 1850, lists the widow Hannah; children, Henry, John, Linus, Lovina, wife of Philander Buckley, and Nathan, all residing in the Town of Clarkson and of full age; sons Barnabas and Reuben, minors under 21 years, of Clarkson; and grandchildren, William, Alminaette, DeGroff and George H. Shears, children of J. D. Shears and a deceased daughter (not named) of the deceased. [Estate of Hendy Quivey, L.A. 2:576, Monroe Co. Surrogate's Office, Rochester, N.Y.]

Hannah Quivey of the Town of Clarkson bought land on Lot 11 in the Triangular Tract from William Young and his wife Jane on 6 Oct. 1852. [Monroe Co. Deeds, 224:431.] On 12 Dec. 1865, Hannah Quivey of the Town of Hamlin sold this land to Reuben Quivey [Ibid., 198:197]; and on the same date Reuben Quivey of the Town of Hamlin leased to Hannah Quivey "his Mother" for her support and use as long as she lived the property she had deeded to him. [Ibid., 197:107.]

He married 20 or 21 Mar. 1829, at Victory, N.Y., PHEBE BOUGHTON, who was born 13 May 1810, at Ridgefield, Conn., and died 21 Sept. 1895, in the Town of Victory, daughter of James B. and Sarah (DeForest) Boughton. Mr. and Mrs. Quivey are buried in the French Cemetery in the Town of Victory.

About 1821 Nathaniel Quivey settled in the Town of Victory, Cayuga Co., N.Y., where he bought a farm on Lot 40 from Joseph Hodges of the Town of Brutus on 22 Jan. 1824. [Cayuga Co. Deeds, FF:358.] He purchased additional land from John W. Hulbert of Auburn, N.Y., on 1 July 1828. This parcel began at the southeast corner of the land formerly owned by John Hart and then in the possession of Hendy Quivey. [Ibid., II:115.] On 22 Feb. 1842, he sold a piece of land to his brother Hendy. [Ibid., 67:194.] The Nathaniel Quivey farm was in the western part of the Town of Victory west of Victory village and near the French Cemetery where the Quiveys are buried.

Mr. and Mrs. Quivey are buried in Huron Evergreen Cemetery.

In 1830 Barnabas Quivey was living in the Town of Butler, Wayne Co., N.Y., where he purchased land on 14 Nov. 1835. [Wayne Co. Deeds, 19:110.] In 1838 Barnabas Quivey of the Town of Butler bought two parcels of land on Lot 61 in the Town of Ira, Cayuga Co., N.Y.; one on 1 May from Horatio N. Wood and his wife Angeline of Butler and the other on 10 May from Charles Kellogg and his wife Jane of Ira. [Cayuga Co. Deeds, 60:94, 96.] He was enumerated in Ira in the 1840 Census, and on 9 Nov. 1842, Barnabas and his wife Margaret sold their land in Ira to Benjamin Johnson. [Ibid., 66:37.] Barnabas moved next to the Town of Wolcott, Wayne Co., N.Y., where he was enumerated in the 1850 and 1860 Censuses. In 1865 he was living once again in the Town of Butler but by 1870 he established his residence in the Town of Huron, Wayne Co., where he lived the rest of his life. The death of Barnabas Quivey appears in The Lake Shore News, Wolcott, N.Y., Thursday, 24 Feb. 1881, p. 3, col. 7: "Quivey.- In Huron, Feb. 20th, 1881, Barnabas Quivey, aged 78 years."
