MORTUARY MATTERS

Funeral of the Late W. T. Small Largely Attended
The funeral services over the remains of William T. SMALL superintendent
of motive power of the Buffalo, Rochester & Pittsburg railroad, were held at
his late home, No. 93 Clifton street, at 4 o'clock yesterday afternoon. The
services were conducted by Monroe Commandery, No. 12, Knights Templar, of this
city, and were followed by a private prayer service at 5 o'clock, Rev. Dr. DOTY,
of Christ Church, officiating. The services were largely attended by
relatives and friends and the employes of the Lincoln Park shops, the attaches of the
motive department office and many railway men, with whom Mr. SMALL was
unusually popular and had a wide acquaintance. In the morning the employes of the
Bradford shops arrived on a special train and visited the house, but were obliged
to return home before the funeral services. Besides many beautiful floral
tributes from immediate friends, was a floral locomotive and tender from the
employes of the Lincoln Park shops, a wreath from the attaches of the office of
the motive department, a broken column from the engineers of the road, a pillow

from the employes of the Bradford shops and a Maltese cross from the Knights Templar.

The remains were taken to Toronto for burial. The service will be conducted under the charge of the Knights Templar of that city to-day. Messages of condolence were received from many of Mr. SMALL's railroad acquaintances who were unable to be present, among the most prominent of whom were Mr. SMALL's brother, H. J. SMALL, of Sacramento, Cal., superintendent of motive power on the Southern Pacific; G. W. CUSHING, of Lexington, Ky., of the Queen & Crescent route; J. McNAUGHTON, of Milwaukee, Wis., superintendent of motive power on the Wisconsin Central; William O'HERIN, of Parsons, Kas., superintendent of motive power on the Missouri, Kansas & Texas; B. HASKELL, of Grand Rapids, Mich., superintendent of motive power on the Chicago & West Michigan; John HICKEY, superintendent of motive power on the Northern Pacific, and M. L. HINMAN, president of the Brooks Locomotive Works of Dunkirk, N. Y. A FRENCH and D. C. NOBLES and wife, of French Car Spring Company, Pittsburg, attended the funeral.

FLORA NEWCOMB WEBSTER.

Sad Death of the Young Wife of William WEBSTER of Mendon. PITTSFORD, June 2. The death of Flora NEWCOMB, wife of William WEBSTER of Mendon, occurred last evening in Rochester at the private hospital of Dr. WHITBECK on Park avenue. Mrs. WEBSTER had been ill about seventeen weeks, fourteen of which had been spent in the hospital where she had undergone several operations. She was the second

daughter of Mrs. Julia NEWCOMB, who survives, was born twenty-six years ago in the town of Mendon, where she resided until a few years ago, when she went to Rochester to study the profession of a trained nurse, remaining there until shortly before her marriage, which took place last December at the residence of her uncle, Royal TOBEY of Rochester. Mr. and Mrs. WEBSTER resided at Mendon after their marriage until she went to Rochester, which was the beginning of the sad end. Mrs. WEBSTER was a well known and popular young person in this vicinity and had many friends, who are grieved to hear of her death. WEST BLOOMFIELD, June 2. Before Justice of the Peace C.M. HENDEE yesterday Mortimer LEAK was arraigned for having violated the game law in killing one pheasant. After hearing the testimony on both sides the jury brought in a verdict of no cause for action.

MEMORIAL SERVICE.

Word for Missionaries Who Have Died Work of the Living. CLIFTON SPRINGS, June 2. Part of the time yesterday was given up to a memorial service by the members of the missionary conference. Eleven have died during the year, Rev. George E. STONE was born 1873, graduated from Hamilton College 1895, and Auburn Theological Seminary 1898. In August, 1898, he sailed from New York for Arabia as missionary. He died in June, 1899. He attended the I.M.U. of Clifton Springs in 1898.

Rev. John SCUDDER, M.D., of India, died May 23, 1899. He was the youngest son of Dr. John SCUDDER, the well known missionary. Rev. Samuel R. HOUSE died August 1?, 1899 aged 82 years. He went to Siam in 1847, and was one of the founders of the Siam and Laos missions.

Mrs. F.P. GILMAN died September 16, 1899. Mrs. GILMAN was one of the first missionaries to Hai?an.

Other names were read and comments on their lives made. Rev. M. CRANE led a meeting during his discussion of "Education as a Factor in Overcoming Tradition and Superstition." Rev. Dr. RIGGS advocated teaching the English language. Miss SHATTUCK told of the work in the training school in Turkey. Dr. Lauren said there are 30,000 young Hindoo men in the colleges of India.

Rev. T. WHYTOCK of Africa gave a very interesting talk on his work on the Congo. Eleven years ago the first mission was started. Eight missionaries went out. Now there are seven stations 100 miles apart and sixty or seventy workers. Twenty-five have died in this time. The people were cannibals, ignorant and cruel.

HEALTH REPORT.

Thirty-Five Deaths Reported for the Present Week.

The health registrar reports thirty-five deaths for the present week against forty for the corresponding week of last year. Of the decedents this week two were less than one year old, six between 50 and 60, eight between 60 and 70, three between 70 and 80, four between 80 and 90 and one over 90 years of age.

Among the causes to which death is ascribed are the following: Heart disease, 6; kidney disease, 5; apoplexy, 4; consumption, 3; whooping cough, 3. Twenty-two of the decedents were males and thirteen females.

FUNERAL OF MRS. INGLIS.

Held From the Morgue This Morning Husband Charged With Murder. The funeral of Mrs. George INGLIS, who died at the Homeopathic Hospital last Monday night, was held from the public morgue at 9 o'clock this morning.

Mrs. INGLIS is alleged to have been murderously assaulted by her husband, George INLGIS, in the family home at the rear of 85 Stone street, a week ago Thursday night. An autopsy was performed on the body of the woman and death was found to have been caused by pneumonia and meningitis. It is not known whether the injuries supposed to have been received by the woman caused her death or not. At the inquest conducted recently by Coroner KLIENDIENST INGLIS was held responsible for his wife's death. INGLIS is now in jail on the charge of manslaughter.

YESTERDAY A DAY OF SAD TRAGEDIES

South Livonia Man Killed In His Barn By Lightning A Girl Ground to Death Miss Sullivan Instantly Killed at Lockport on Her Way to Church --Edward Wescott, of Kanona, Found a Shapeless, Bleeding Mass Near His Home

Andrew KIEDER, who lived near South Livonia, on the Conesus side of the road that divides that town from Livonia, went to his barn between 6 and 7 o'clock yesterday morning. Soon after the rain and electric storm that passed over that section burst with considerable fury, accompanied with sharp thunder. His family heard a peculiar rumble and shattering noise, and going into the barn found him dead. The fluid had struck his head, burning his face and blackening his right arm.

No fire had been communicated to the building and hardly a trace of the entrance or exit of the bolt that did the work was to be found. Mr. KUDER was 60 years old, a lieutenant in the Civil war, a member of

the E. S. Gilbert G. A. R. Post and a Mason. He had attended a meeting of his Masonic Lodge Saturday evening at Livonia village. Mr. KUDER was a farmer and a well-known citizen. He leaves a widow, a son and two daughters. Nothing has so shocked the people of Livonia, Conesus and Groveland, his native town, in many years.

STRUCK BY A TRAIN

Kanona Man's Mangled Body Found Within Sight of Home

Edward WESCOTT, of Kanona, in the town of Bath, met with a terrible death about 2 o'clock yesterday morning, being struck and run over by an Erie freight train. The remains, scattered for a considerable distance along the railroad tracks, were discovered by a track walker about 5 o'clock yesterday morning. WESCOTT resided with his family in a house in close proximity to the Erie depot, and he was no doubt on his way home when he was killed. He had evidently walked up the railroad tracks, intending to cut across the field to his home, thereby making his walk shorter. He was struck a few feet west of the Erie depot and about 200 feet distance from his home. It is quite likely that he was killed by an Erie freight train which passes through Kanona about 2 A. M. His body was literally cut in pieces and rolled into a shapeless mass. Only a part of the head remained intact and his features were unrecognizable by his friends. His brains were scattered several feet along the tracts and ties which were covered with blood.

As soon as the remains were discovered Coroner John T. HORTON of Hammondsport, was notified of the accident and he left at once for the scene. He ordered the remains picked up. They were placed in a box and made ready for burial. Overseer of the Poor George MURRAY, of Bath, was applied to dispose of the remains and he notified Superintendent of the Poor William C. ACKER, who had the remains buried yesterday afternoon in the cemetery at Wheeler at the request of the family of the deceased. WESTCOTT was employed as foreman in the mills of the Kanona Lumber Company. He was about 40 years of age and leaves a widow and four children in moderate circumstances.

YOUNG GIRL'S AWFUL DEATH

Miss Rose Marie Sullivan, of Elmira, Ground Under an Engine

One of the most horrible accidents which ever took place in Lockport occurred at 10:05 o'clock yesterday morning at the Caledonia and Hawley street crossing of the New York Central & Hudson River railroad. Miss Rose Marie SULLIVAN, daughter of a prominent and wealthy Elmira citizen, was instantly killed by the Central express train from Buffalo, which is due in Lockport at 10:00 o'clock every Sunday morning.

The accident was an unusually unfortunate one. Miss SULLIVAN went to the city Wednesday to be the quest of Miss Monica HUSTON, daughter of ex-Alderman and Mrs. J. Charles HUSTON, of Caledonia street. At 9:58 o'clock the young ladies left the HUSTON residence and started for St. Patrick's Church on Church street. They proceeded down Caledonia street to Hawley where the Central-Hudson crossing is. Hardly had they reached the crossing planks when the express train came rushing along at a good rate of speed. The girls stopped for a second, and then Miss SULLIVAN, evidently thinking she had ample time to cross in safety, ran forward. Miss HUSTON called to her, and Louis H. HUSTON, a brother of Miss Monica HUSTON, sprang forward from the other side of the crossing to stop the young lady before she was squarely upon the east-bound track. Flagman OATS also rushed up, but before any of them reached Miss SULLIVAN she was directly in front of the huge engine and in another second she lay twenty-five feet from the rails a bruised mass of flesh and bone. Drs. H. H. MAYNE, Alexander McNAMARA, J. Carl BLACKLEY, William H. HODSON and J. Charles PREISH were on the scene in a few minutes. Miss SULLIVAN breathed a few minutes and then passed away. Coroner Henry L. CLEVELAND was notified and went at once to the scene where the fatality occurred. The train had stopped and all hands connected with it were standing about the body when the coroner arrived. He at once released them and the express resumed its eastern journey. The body was taken back to the HUSTON residence and later to

PRUDDEN Brothers' morgue on Main street. The young ladies father was notified by wire and the remains will be taken to Elmira to-day for interment. Coroner CLEVELAND will hold an investigation.

Miss SULLIVAN was a well-educated young girl and popular with all. She was just past 16 years of age. Besides a father she leaves two brothers and one sister to mourn her loss.

Death at Geneva Sanatorium of One of Syracuse's Oldest Business Men

At the sanatorium in Geneva Saturday occurred the death of William E. ABBOTT, a prominent and wealthy resident of the city of Syracuse, at the age of 77 years. Deceased had been at the Geneva sanatorium for the past two or three months, going there from Clifton Springs where he suffered a stroke of paralysis from which he never recovered. His wife and a niece from Utica were with him when he died.

Mr. ABBOTT was born in Lowville, January 19, 1822, and was educated at Gouverneur and Lowville academies, and a preparatory school in Oberlin, Ohio. He began his business career in the city of Utica in the year 1838, when he was 16 years old, where he served as a clerk in dry good stores for nearly four years. He removed to Syracuse at the end of his apprenticeship and located the first dry goods store there in 1842, purchasing the stock owned by F. W. ANDREWS, brother of Judge Charles ANDREWS, former chief justice of the court of appeals. Associated with him was his brother Henry G. ABBOTT. The stock they purchased was a general one. They sold out everything but the dry goods, which business he conducted exclusively for the next thirty-five years. It was thus he earned the distinction of being the oldest dry goods merchant in Syracuse. Mr. ABBOTT subsequently went into the coal business for a few years, making a period of fifty-seven years during which he was in active business life in the Salt city. During that time he earned for himself an enviable reputation as a man of affairs and a public-spirited citizen. He took especial interest in the public and charitable institutions of Syracuse. He was for three years inspector of the penitentiary and twice elected supervisor. He was one of the incorporators of the Onondaga County Savings Bank, of which institution he was vice-president at the time of his death, and in the affairs of which he took an active interest, giving much of his time and personal attention to the management. He was a Republican in politics, being instrumental in forming that party in New York state. In the days of slavery he was a strong abolitionist and aided between 300 and 400 slaves to obtain their freedom through the underground railroad. He was present at the Jerry Rescue and very influential in politics.

I just read your word docs attached. Thanks for the information! One note - Selah (Celia) Cheney was not born in Sharon, Litchfield. Her Father Zebulon Tyler was born and raised in Windham County, Brooklyn and Canterbury. She was baptized in South Killingly, Windham with her mother Betty, of Pomfret and Canterbury. Neither Joseph or Selah were in Litchfield. Way too much info, but I have found a lot of very good info on Joseph and Selah (did you ever see the South Killingly Church records that show Betty, wife of Zebulon Tyler, bapt with her daughter Selah and son Abijah? June 20, 1770). As you know, Joseph moved to Vermont, as did Elizabeth and her husband above, just about the same time. Selah's uncles moved to the same county, Orange Vt. at about the same time - Phineas Tyler and Oliver Tyler (who married Abigail Warren) and Noah Adams and Chester Adams.

This article, and the subsequent one, "John Black of Charlestown Was Really Robert Blott" by Robert Charles Anderson both concur, by the way, that Robert had only one wife, Susanna Selbee.

Sarah is buried in the Old South Cemetary.

That Lt. Richard Park, of Concord, was not identical with Richard, son of Thomas, is easily proved by the following considerations:

They had children Joseph born 1691, Elizabeth born 1693, Sarah born 1696 Josiah born 1698 and Abigail born 1700; just in the very decade of years that Richard the son of Thomas, was on Mr. Jackson's authority having quite a different lot of children born at Newton. 2nd. Lt. Richard Parks, of Concord, died June 19, 1725, in the 5th year of his age; his tombstone being the authority. This would bring his birth in the year 1667 or 1668. While all previously published accounts give but three children to Richard1 Parke, and have entirely, ignored the existence of a second Richard; there seem to be very good reasons for believing that this second Richard was the oldest son of Richard'. Notwithstanding the fact that the first Richard dying in 1665, named in his will no son but Thomas, I am still convinced that this Richard of Cambridge Village was his son, who being older than his brother Thomas, had already received his portion of his father's estate during the lifetime of his father. The will of the first Richard Parks is a curious document; written partly in the first person and partly in the third person; obviously dictated; not mentioning by name his wife or either of his daughters, and with a meaningless and shapeless blot in place of a signature, as if the baud that held the pen were already too weak to write.

After the war Richard was married in Sudbury; and he and his wife remained at Sudbury until after 1689, the last date of a birth recorded for them there. By: William Adams Kemp, October 31, 2002 9:46pm) Rachel Cloud in her research says that the Mass Court Records Vol 5 states...that Francis Adams, widow of James had 150 acres of land laid out to her by the Mass General Court. south of Lancaster, MA. Francis' son Richard was with her. If this was true then there must have been another Richard Adams born later on. I have not found this record however. She says it was reported in Our Quaker Ancestors by Wesley on page 72. I have not been able to track this source.

The problem is that James and Frances (Vassall) Adams's recorded son Richard died soon after birth. It is argued by some that this Richard is an unrecorded son. Hayward argues that the vital records of Sudbury and the will of Richard Adams make it clear that these are the same person. The land records of Canterbury, Norwich and Plainfield show that there were two Richard Adams: an uncle and a nephew, who was of age in 1701. The vital records of Sudbury show a son Richard born to William Adams on 22 Aug 1678. It is reasonable to assume that Richard and William were brothers, and both were the son of James.

Richard Adams died on 24 Aug 1728 in Norwich. He married Rebecca Davis on 24 Jun 1679 in Sudbury. Who was Rebecca Davis? It is sometimes claimed, without evidence, that she is the daughter of Robert and Bridget (Loker) Davis of Sudbury. (See Marrotte.) This is consistent with her being married in Sudbury and Savage says that Robert and Bridget had surviving daughters Sarah and Rebecca. However, Sarah's birth is recorded in Sudbury, while Rebecca's is not. In his 17 (5) 1655 will, Robert Davis left his house, land and moveables to his wife Bridget. He mentions his daughter Sarah, but not Rebecca. It is possible, however, that Bridget was born after he signed his will. After her husband's death, Bridget Loker married Thomas King. In his will, Thomas mentions Sarah's husband John Brigham, but not Rebecca.

Richard was a member of Capt. Mosely's company from Sudbury in King Philip's War. After the fighting on 19 Dec 1675, he was listed as one of nine wounded men at Rhode Island on 6 Jan 1676. Richard was an early freeholder of Plainfield, living on the west side of the Quinebaug on 24 Dec 1702 (.Hayward, Kendall, "Richard Adams of Sudbury, Mass.; Plainfield and Norwich, Conn.," The American Genealogist 23, 1946, 141-149, Addenda 24, 1948, 193).
